### MESSAGE FROM ERA'S PRESIDENT

December 7, 2014 marked the historic relocation of the ERA's Sprague Library out of Grand Central Terminal's 4<sup>th</sup> Floor. This move was necessitated by termination of the lease with Grand Central Terminal. Photos, negatives, and other digital images as well as research and corporate records have been relocated to newly renovated and ultra-modern climate controlled facilities in Inwood. The balance of the 8,000+ volume Sprague Library collection will ultimately relocate to the Shore Line Trolley Museum in East Haven, CT, whose vision includes launch of a new catalogued research library, with the ERA Sprague Library as its foundation. This library promises more public access and usage and staff attention than has been possible than at Grand Central.
